

THE NATIONAL INSURANCE ACT

The National Insurance (Increase in Benefits) Order, 2010

In exercise of the powers conferred upon the Minister by section 23A of the National Insurance Act, and of every other power hereunto enabling, the following Order is hereby made:-

1. This Order may be cited as the National Insurance (Increase in Benefits) Order, 2010, and shall be read and construed as one with the National Insurance Act (hereinafter referred to as the principal Act) and all amendments thereto.

2. - (1) The provisions of the enactments specified in the first column of the Schedule are amended in the manner specified in the second column of the Schedule.

(2) The amendments referred to in sub-paragraph (1) shall take effect from the 1st day of July, 2010.

In relation to sub-paragraphs (a) and (b) of paragraph 2 (widow's and widower's benefit) -</p> <p>(a) in column 2 under the sub-heading "Basic", delete the figures "\$2,000.00" wherever they appear and substitute therefor in each case the figures "\$2,400.00";</p> <p>(b) in column 3, under the sub-heading "Basic", delete the figures "\$30,000.00" and substitute therefor the figures "\$40,000.00".</p> <p>3. In relation to paragraph 3 (orphan's and special child's benefit) -</p>

- (a) in column 2, under the sub-heading "Basic", delete the figures "\$3,500.00" and substitute therefor the figures "\$4,200.00";
 - (b) in column 3, under the sub-heading "Basic", delete the figures "\$40,000.00" and substitute therefor the figures "\$48,000.00".
4. In relation to paragraph 4 (employment injury benefit), in column 2 under the heading "Additional Pension", delete the figures "\$2,500.00" and substitute therefor the figures "\$3,200.00".
 5. In relation to paragraph 7 (funeral grant), in column 3, under the sub-heading "Basic", delete the figures "\$60,000.00" and substitute therefor the figures "\$70,000.00".
