## NOTICES OF MOTIONS GIVEN ORALLY

Reverend Ronald Thwaites gave notice that at the next meeting of the House he would move the following motions:

**1**. WHEREAS hundreds of Jamaican are killed or suffer injury and economic loss each year as a result of road accidents;

AND WHEREAS a heavy and unnecessary burden is placed on public expenditure;

AND WHEREAS driver incompetence, indiscipline and incapacity and defective vehicles have been identified as major contributory causes to road accidents:

BE IT RESOLVED that this Honourable House recommend to Government:

- (i) The need for a revised code and appropriate enforcing authority for driver education and testing.
- (iii) To improve the integrity of the prevailing system of vehicle inspection.
- (iii) consider amendments to the Road Traffic Act which:
  - a) would prescribe mandatory driver re-education for traffic offenders at the discretion of the court.
  - b) provides for the obligatory recertification of all holders of drivers licenses at intervals of fifteen years after issue.

AND BE IT FURTHER RESOLVED that all of these measure be done at the cost of applicants.

- 2. BE IT RESOLVED that this Honourable House review the policies governing the relationship between the Churches in Jamaica and the State with respect to the sponsoring and support of education with a view to advancing the involvement and influence of religious organizations in expanding educational opportunity and improving quality.
- **3**. BE IT RESOLVED that this Honourable House debate the adequacy and affordability of loan financing for students in the Jamaican tertiary education system.
- **4**. BE IT RESOLVED that this Honourable House debate the cost of remediation in the public education system and treat with ways in which this can be reduced.

#### **BUDGET DEBATE**
