PRIVATE MEMBERS' MOTIONS

NOTICE GIVEN ON TUESDAY, 29TH JANUARY, 2013

1. Dr. Baugh - To move -

[No. 1]

WHEREAS the issue of hospitals user-fees is topical at this time, having been the subject of debate for decades;

AND WHEREAS user-fees at the point of service, demanding out-of-pocket payments to raise revenue for the health sector, were in place for more than twenty years and appears to be under consideration for re-introduction:

AND WHEREAS it has been proven beyond a doubt that a means test at the point of service, to identify those able to pay, has proven futile and regressive, necessitating various forms of sanctions, including withholding allied services such as birth and death certificates, thereby imposing additional hardships on the people when they are most vulnerable;

AND WHEREAS there was a consequential 14.4% decline in the total utilisation of the public health services, and a 24% decline in the utilisation of primary health services in the period 1994-2002; when user-fees increased as budget cuts were implemented;

AND WHEREAS this burden of costs was imposed on the poorest quintiles that are largely unemployed or under-employed and who are dependent on public health services;

AND WHEREAS liabilities accrued by individuals to public institutions caused embarrassment, resulting in the postponement of clinic and hospital visits, causing a delay in treatment and a resultant higher incidence of costly complications:

BE IT RESOLVED that this Honourable House appoint a committee to sit jointly with a similar committee from the Senate to evaluate the extensive reviews that have been done on Jamaica's user-fee policy, as well as to draw upon the experience of other countries and the Jamaican private sector, to achieve comprehensive universal coverage that is affordable to the people of Jamaica, eliminating the barriers to adequate health care.

NOTICE GIVEN ON TUESDAY, 5TH FEBRUARY, 2013

Mr. Samuda – To move –

[No. 2]

WHEREAS inordinate delays are being experienced across the country in the execution of approved projects under the announced Jamaica Emergency Employment Programme (JEEP) 2 scheme;

AND WHEREAS there appears to be an unnecessary overlapping of activities, leading to a lack of proper coordination between the departments under the portfolio of the Ministry of Transport, Works and Housing, which have responsibility for the management of this important project;

AND WHEREAS this has led to a state of confusion and uncertainty, which, if allowed to continue, may severely compromise the successful completion of important infrastructure projects throughout the country;

AND WHEREAS this situation represents a source of frustration for Members of Parliament and other important stakeholders:

BE IT RESOLVED that the Honourable House call on the Minister of Transport, Works and Housing to present to Parliament a comprehensive report as to the progress of the projects under JEEP 2;

AND BE IT FURTHER RESOLVED that the Minister advise the Honourable House if and when any changes are contemplated to the existing methods of executing this critical programme.

NOTICE GIVEN ON TUESDAY, 26TH FEBRUARY, 2013

3. Miss Grange - To move -

[No. 3]

WHEREAS Jamaica's national emblems and symbols are representative of our people, heritage, values and hopes for the future; created as visual triggers from both Jamaicans and foreigners alike;

AND WHEREAS it is unacceptable to have images of Jamaica's national flag or any other of Jamaica's national emblems and symbols being desecrated;

AND WHEREAS the recent burning and trampling on of the Jamaican flag in a television advertisement produced by a foreign company has reinforced the need for the formulation of policy guidelines and legislative framework regarding Jamaica's national emblems and symbols;

AND WHEREAS the Minister of Youth, Sports and Culture, under the former Administration, had established an inter-ministerial committee, comprising representation from the Ministry of Youth, Sports and Culture, the Jamaica Intellectual Property Office, the Office of the Prime Minister, the Institute of Jamaica, the National Library of Jamaica, and the Attorney General's Chambers, among others, to formulate policy guidelines for the management and regulation of the use, display and performance of Jamaica's national emblems and symbols, and the enactment of appropriate legislation to give legal force and effect to the guidelines, as proposed;

AND WHEREAS the use, display or performance of the national emblems and symbols continue to be handled in *an ad* hoc manner, with no specific agency providing definitive guidance with respect to their usage, with the exception of an incomplete draft Handbook of National Symbols (Office of the Prime Minister, 2004) and A Code for National Symbols;

AND WHEREAS others continue to secure significant financial benefits from the usage of Jamaica's national emblems and symbols, while Jamaica receives little to no financial gain;

AND WHEREAS it is important to note that there is no legislative framework at this time which governs the use and management of the national flag even though it is particularly crucial that we regulate and manage the use of the national flag and the name of the country, in order to strengthen international lobbying and increases protection from abuse and misuse;

AND WHEREAS countries such as Canada, Nigeria, Australia and Trinidad and Tobago have all enacted legislation which governs the use of their national flags, coats of arms and other national symbols;

AND WHEREAS the completion of the work of the previous Administration will ensure that Jamaica's national emblems and symbols are better safeguarded from abuse:

BE IT RESOLVED that this Honourable House call on the Government to continue the work of the inter-ministerial committee, put in place by the previous Administration, regarding the formulation of policy guidelines for the management and regulation of the use, display and performance of Jamaica's national emblems and symbols and the enactment of appropriate legislation to give legal force and effect to the guidelines, as proposed;

AND BE IT FURTHER RESOLVELD that this Honourable House call on the Government to proceed with the expansion and finalisation of the Handbook for National Symbols and Emblems as a reference publication for providing guidance on the management and regulation of the use, display and performance of Jamaica's national symbols and emblems.

NOTICE GIVEN ON WEDNESDAY, 29TH MAY, 2013

4. Miss Grange - To move -

[No. 4]

WHEREAS the treatment of children in the care of the State is a matter of national concern, which has for too long, remained sub-optimal;

AND WHEREAS the incarceration of children deemed "uncontrollable" and the holding of adolescents at adult correctional facilities have been among primary concerns in this regard;

AND WHEREAS, in March 2013, the Office of the Children's Advocate submitted to Parliament recommendations regarding the care of children deemed "uncontrollable", and the holding of adolescent girls at the Fort Augusta Adult Correctional Facility, which recommendations are geared at improving the treatment and rehabilitation of such children:

BE IT RESOLVED that this Honourable House urgently debate and adopt the recommendations Tabled by the Office of the Children's Advocate.

NOTICE GIVEN ON WEDNESDAY, 12TH JUNE, 2013

5. Dr. Duncan - To move -

[No. 5]

BE IT RESOLVED that the Annual Report of the Committee appointed to examine and recommend for approval proposed Estimates for Constituency Projects, submitted to the Constituency Development Fund by respective Members of Parliament for the year 2012-2013, which was laid on the Table of the House of Representatives on the 12th day of June, 2013, be adopted.

NOTICE GIVEN ON TUESDAY, 23RD JULY, 2013

The House to continue debate on the motion –

[No. 6]

WHEREAS the economies and fortunes of Europe, including Great Britain, were largely built upon the slave trade and slave labour;

AND WHEREAS the British Parliament passed the *Slavery Abolition Act, 1833*, which abolished the slavery system under which the British slave owners were guaranteed an endless supply of free labour, which was critical to the productivity of their holdings;

AND WHEREAS, by further political action, the British Parliament paid to the British slave owners a sum of £20M as economic compensation for the loss of the slaves who formed a major component of their production engine;

AND WHEREAS no similar political action was taken by the British Parliament to compensate the former slaves or their descendants for their labour, which built the economies of Europe, including Great Britain, nor were the former slaves allowed to own land;

AND WHEREAS the former slaves and their descendants should have been paid for their labour, which built the economies of Europe, including Great Britain;

AND WHEREAS the Caribbean Community (CARICOM), of which Jamaica is a member, took a decision to form a committee to oversee the work of a CARICOM Reparation Commission on July 6, 2013, to pursue reparation claims against Great Britain and other slave trading countries;

AND WHEREAS the Rastafari have had their case for reparation to Africa approved by this House; and a National Reparation Committee was established by this Honourable House:

BE IT RESOLVED that this Honourable House debate the issue, as set out in the prayer, and make the political decision by a vote that the Government of Jamaica is entitled, on behalf of the former slaves and via the basic tenets of labour law and human rights, to receive payment from Great Britain, equivalent to the sum paid to the British slave owners as compensation for the loss of slave labour;

BE IT FURTHER RESOLVED that the payment be used to clear off all the debt of Jamaica and to improve the education, infrastructural development, and health sectors, and a portion be set aside for the repatriation of African Jamaicans to Africa;

AND BE IT FURTHER RESOLVED that this Honourable House enjoin other CARICOM countries to make similar political decisions on this matter, and that this Honourable House instructs the Government of Jamaica to take this case of genocide to the International Court of Justice to value the economic cost of chattel slavery to Jamaica and the further compensation that should flow for the abuse of human rights and the attendant denial of culture and history, murder, rape and wanton abuse of power in flogging, branding, and denial of freedom of movement, freedom to worship, freedom to own land, and the right to education, which were the hallmark of slavery.

7. Dr. Baugh – To move –

[No. 7]

WHEREAS the Minister of Health is empowered under the *Public Health Act* to provide regulations for the maintenance of the health and well-being of the nation;

AND WHEREAS the Minister made regulations to restrict and prohibit the smoking of cigarettes in various public spaces;

AND WHEREAS these regulations have not been fully circulated and presented to Parliament:

BE IT RESOLVED that these regulations be Tabled in the House and referred to the Human Resource and Social Development Committee for immediate review and for its recommendation.

NOTICE GIVEN ON TUESDAY, 29TH OCTOBER, 2013

8. Mr. Vaz – To move –

[No. 13]

WHEREAS there is a constant lack of potable water from the National Water Commission (NWC) and the Portland Parish Council sources due to severe drought and a dysfunctional water supply system, which has become a source of frustration and inconvenience, and further poses a health hazard with the possibility of an outbreak of disease;

AND WHEREAS this lack of potable water has resulted in the closure of businesses and schools and the disruption of the daily lives of the constituents residing in a number of communities in Western Portland, some of whom have now resorted to public demonstration and the blocking of roads as a means of appealing to the relevant authorities;

AND WHEREAS funds totalling Five Million One Hundred and Sixty-three Thousand Two Hundred Dollars (\$5,163,200) have been spent, since January 2013, from the Member of Parliament's Constituency Development Fund allocation, as well as funds from the Ministry of Water, Land, Environment and Climate Change, Ministry of Local Government and Community Development and the Portland Parish Council; notwithstanding, these funds have proved inadequate to alleviate the water woes of the residents:

BE IT RESOLVED that the NWC, the other above-named public sector entities, and the Office of Disaster Preparedness and Emergency Management treat the water situation in Western Portland as a situation of dire emergency, and release emergency funds to assist in the scheduled delivery of water to the affected areas;

BE IT FURTHER RESOLVED that the Government of Jamaica formulate a long term sustainable plan to make provision for an adequate water supply system, not only in the constituency of Western Portland but throughout the entire Parish of Portland, and other parishes which are similarly affected by drought from time to time.

NOTICE GIVEN ON TUESDAY, 5TH NOVEMBER, 2013

9. Mrs. Robinson – To move –

[No. 14]

WHEREAS the country's natural resource endowment such as its beaches, rivers, landscape, flora and fauna are key features of our total offerings as a small island-state;

AND WHEREAS these resources are integral to continued national development, economic expansion and the facilitation of social cohesion;

AND WHEREAS no effort should be spared in ensuring that these resources are preserved and protected for this and generations to come:

BE IT RESOLVED that this Honourable House, particularly as it relates to "Little Dunn's River" and other similar attractions, carefully consider the plight of locals and ventilate the keenly contested issues associated with the current state and use of said facilities;

BE IT FURTHER RESOLVED that the Government consider the options available to us as a country, and come up with a clear and decisive policy as it relates to public beaches and places for recreation that are a part of the natural environment, with a view to making them more accessible and amenable to all Jamaicans.

10. Mr. Bartlett - To move -

BE IT RESOLVED that the deliberations of the Public Administration and Appropriations Committee of the House of Representatives, for the period July to December, 2013, which was laid on the Table of the House on the 4th day of February, 2014, be approved.

NOTICE GIVEN ON TUESDAY, 11TH FEBRUARY, 2014

11. Mr. Mair - To move -

[No. 16]

WHEREAS the Government of China, through China Harbour Engineering Company, and our Government are currently negotiating the development of elements of a logistics hub in Jamaica, and the Chairman of the Port Authority of Jamaica has recently confirmed that a port will be built in the vicinity of the Goat Islands in the Portland Bight Protected Area as part of the logistics hub;

AND WHEREAS the Portland Bight Protected Area, which includes the Goat Islands, the Hellshire Hills and the adjoining coastline, was created in 1999 under the *Natural Resources Conservation Authority Act* because of its biological diversity and important functions, including three fish sanctuaries declared under the *Fishing Industry Act*, six game sanctuaries declared under the *Wild Life Protection Act*, and two forest reserves declared under the *Forest Act*;

AND WHEREAS there has been no detailed disclosure on the scope of works, the precise location and the consequent environmental impact or economic benefit the operations at the Goat Islands port could have on our country, neither has the Government provided sufficient information to the nation as to the reason why the Goat Islands and its

environs would be the best option for a port, and whether or not other sites were considered and rejected;

AND WHEREAS the Environmental Management Scoping Report, commissioned by the Government with the intention of guiding its decision-making, is believed to contain flaws and inaccuracies and is, therefore, an unsatisfactory basis on which to make a pronouncement that is in the best and long term interests of Jamaica, with the concomitant risk of irreversible and devastating ecological impacts if a trans-shipment port, logistics hub, or any form of massive development were to take place on the Goat Islands and its environs:

BE IT RESOLVED that this matter be referred to the Infrastructure and Physical Development Committee of this Honourable House for it to take the necessary steps to enquire into the benefits and/or losses that our country could incur if any part of the Portland Bight Protected Area were to become part of the logistics hub;

AND BE IT FURTHER RESOLVED that the Government of Jamaica put on hold any final agreement with China Harbour Engineering Company for the development of a logistics hub in Jamaica until this Honourable House receive and deliberate on the report from the Infrastructure and Physical Development Committee.

NOTICE GIVEN ON TUESDAY, 18TH FEBRUARY, 2014

12. Mr. Chuck - To move -

[No. 17]

WHEREAS it was anticipated that the Electoral Commission would be responsible for the national registration and identification of all citizens;

AND WHEREAS the electoral commissioners, the returning officers and electoral offices are not fully employed outside the election periods, and are presently under-utilised:

BE IT RESOLVED that the Government bring the relevant legislation to start and complete the national registration and identification system to Parliament urgently;

BE IT FURTHER RESOLVED that the Electoral Commission be renamed as The National Registration Commission to register every Jamaican citizen from birth or naturalization;

AND BE IT FUTHER RESOLVED that the Electoral Commission (renamed The National Registration Commission) continue its work to oversee and conduct national elections.

NOTICE GIVEN ON TUESDAY, 25TH FEBRUARY, 2014
