AND WHEREAS 37.85%, or 425,400, of the country's labour force is in the informal sector, including persons earning minimum wage or in law-paying jobs, such as domestic workers and others working in private household; and do not have the full protection of the law and, therefore, cannot readily access mechanisms to seek redress where their rights have been infringed by their employers;

AND WHEREAS the labour laws, including the *Minimum Wage Act*, do not adequately protect the rights of the working poor in Jamaica, creating a gap in the law which contributes to the sexual harassment, exploitation, discrimination and underpayment of those employed persons who do not fall within the rubric of these laws;

AND WHEREAS Jamaica has ratified the International Convention on Economic, Social and Cultural Rights in 1975, which requires the Government to recognise the right to just and favourable work conditions;

AND WHEREAS it is incumbent on Jamaica to fully protect the rights of all those persons, including those employed in spaces that have not been traditionally considered "places of work", such as domestic workers:

BE IT RESOLVED that Jamaica take steps to expeditiously incorporate the provisions of the recently ratified ILO Convention 189 into national legislation by September 2017;

BE IT FURTHER RESOLVED that we take steps to improve the gaps in legislation to protect and safeguard the rights and well-being of workers, particularly minimum wage earners and others who are in low-paying jobs, by December 2018;

AND BE IT FURTHER RESOLVED that the Government conduct a comprehensive review of the current minimum wage with a view to explore practical ways of increasing it to a more liveable wage over the next four years, to better enable persons to meet their basic expenses;

AND BE IT FURTHER RESOLVED that the Government improve mechanisms to promote gender equity and protect the livelihood of women by enforcing and amending, where necessary, the *Employment (Equal Pay for Men and Women) Act, 1975*, to close the pay gap between men and women:

AND WHEREAS the latest UNICEF State of the World's Children report finds that over 85% of Jamaican children, between the ages of 2 and 14, experience violent discipline in their lives; and child neglect in Jamaica ranks number one in reports of abuse received by the Office of the Children's Registry;

AND WHEREAS research concludes that early adversity, toxic and post-traumatic stress harm the developing brains and bodies of children and, if not addressed, can likely result in the children becoming violent adults, and adversely affect their health; and too many Jamaican children already suffer from low self-esteem and live in constant "fight or flight" mode without guidance, time and patience from parents, caregivers or schools;

AND WHEREAS current realities in Jamaica have rendered violent, vulgar and abusive lyrics commonplace in some of our music, and search phrases such as "Jamaican School Girl", on **Google**, lead to pornographic websites:

BE IT RESOLVED that the Houses of Parliament debate the need for a restructuring of current educational methods and/or development of new methods to ensure a reinforcement of basic values and attitudes, and the building of healthy family relationships, as a foundation for making decency, high self-esteem, civility, and patriotism every Jamaican's guiding philosophy.

BE IT RESOLVED that the Report of the Public Administration and Appropriations Committee on its deliberations on the Ministry of Labour and Social Security, which was laid on the Table of the House on the 25th day of July, 2017, be approved.

WHEREAS Judges of the Supreme Court and the Court of Appeal offer dedicated, essential and lengthy years of service to Jamaica, possessing vast and invaluable legal knowledge and experience;

AND WHEREAS, notwithstanding increased life expectancy, most of these Judges are required to retire at a relatively young age, despite being able to continue to offer valuable service to Jamaica and their chosen profession;

AND WHEREAS these Judges may only continue legal practice in constrained circumstances after they retire, and there are few opportunities for employment post retirement;

AND WHEREAS, apart from the Chief Justice and the President of the Court of Appeal, pension entitlements for retired Judges are calculated at the rate of two-thirds of their salaries at the date of retirement;

AND WHEREAS the value of these pensions continuously decreases as economic realities change, rendering them woefully inadequate to allow retired Judges to live in a dignified manner;

AND WHEREAS these Judges lose their health insurance benefits upon retirement, at a time when increasing age often increases the necessity for such health insurance coverage;

AND WHEREAS an unfair and prejudicial disparity exists between the pensions of Judges previously retired and those who will retire in the future;

AND WHEREAS this inequitable state of affairs ought not to be allowed to continue:

BE IT RESOLVED by this Honourable House that:

- (a) The pension of retired Judges be indexed to the current rate of salaries for sitting Judges at the applicable commensurate level, such that pension shall change over time in line with current economic realities;
- **(b)** The rate of pensionable salary for retired Judges be such as is used to compute taxable income thus incorporating, *inter alia*, emoluments and housing;
- (c) This new regime, including the requisite legislative changes, be implemented at the same time as the implementation of the new salary scales for sitting Judges;
- (d) This new regime be implemented retrospectively such that it be applicable from the date of retirement of living Judges who retired prior to its implementation;
- (e) All pension benefits accorded to widows of deceased retired male Judges be equally accorded to widowers of deceased retired female Judges;
- (f) Health insurance benefits accorded to sitting Judges be extended to retired Judges and that this extension be applied retrospectively to living Judges who retired prior to the extension.
