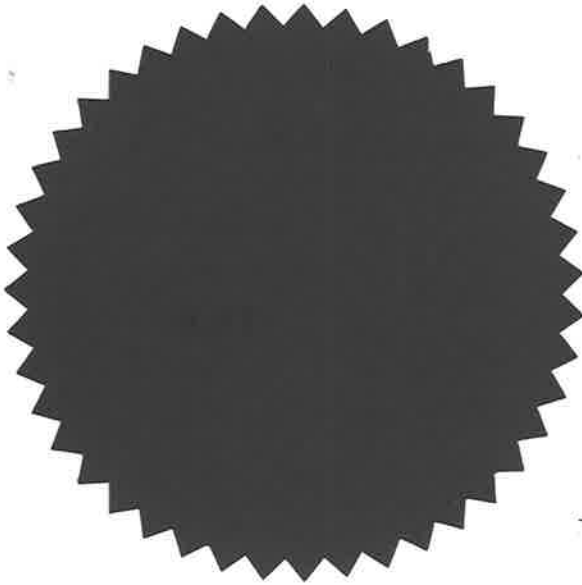

AN ACT to Amend the Road Traffic Act.

*[5<sup>th</sup> day of November 2021 ]*

BE IT ENACTED by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives of Jamaica, and by the authority of the same, as follows:—

1. This Act may be cited as the Road Traffic (Amendment) Act, 2021, and shall be read and construed as one with the Road Traffic Act (hereinafter referred to as the principal Act) and all amendments thereto.

2. The Third Schedule of the principal Act is amended by deleting the Appendix thereto and substituting therefor the following—
